- Why the intersection of race, culture, language, and disability is an urban education issue;
- How issues of race, culture, language, and disability affect students' and their families' quest for an equitable education;
- How to advocate for and provide services to racially, culturally, linguistically, and economically diverse students and their families, and
- The implications of the intersection of race, culture, and disability for urban education practice, research, and policy.
